AGREEMENT

ON this ____ day of March, 1996, IT IS AGREED between Assistant District Attorney Barney Barnett and the Defendant's attorney, James T. Rowan, that the Oklahoma State Bureau of Investigation will make available to James T. Rowan, the following items of evidence:

1. The clothing, including shoes, taken from the deceased body of Robert Anderson;
2. A sample of blood from the deceased, Kathrina Knight;
3. A sample of blood from Hubert Moucka;
4. The blood saturated shirt worn by Moucka at the time he was shot;
5. The blood soaked garments worn by Kathrina Knight at the time she was shot;
6. The sawed off shotgun;
7. The shot cups;
8. The shot extracted from the body of Kathrina Knight;
9. The clothing worn by Joshua Stump at the time of his arrest; and
10. Any other tangible evidence seized from the person or residence of Josh Stump.

The Defendant's attorney agrees to safeguard these items of evidence and to not alter them in any way. The Defendant's attorney will deliver the blood samples and blood soaked clothing to a competent recognized DNA laboratory and the shotgun and shot cups to a ballistics expert for gun shot residue tests. Said laboratories will return the tested items to James T. Rowan and he will return the items to the Oklahoma Bureau of Investigation prior to the commencement of trial.

In the event the prosecutor seeks to admit these items at trial, the defense ~~AGREES~~ not to object based upon chain of custody while in the possession of the defense. In the unlikely event any items are lost while in defense custody, James T. Rowan agrees to enter into a stipulation of fact explaining fully to the jury the facts surrounding the loss of any item. Items will be sent registered mail or some other method which documents accountability.
